### SEPARATION AGREEMENTS

#### **COHABITATION**

Unfortunately the myth of the common law marriage means that many people who live together are not aware that their financial position is not protected. #### PREAND POST-NUPTIAL AGREEMENTS

A pre-nuptial agreement is a document entered into by two people who wish to regulate their financial position as far as possible should their forthcoming marriage come to an end, particularly if one party has children from a previous relationship or previously inherited wealth by way of example. However if you are already married but wish to agree your financial position if you were to separate in the future then a post-nuptial agreement can assist you to achieve this.

### CONTESTED TRUST AND PROBATE

Contested trust and probate includes disputes over the estate of a deceased person. Enoch Evans LLP can assist if you believe a will may have been prepared incorrectly or as a result of undue influence. Enoch Evans LLP regularly deal with bringing and defending inheritance provision claims for individuals who believe they may not have been properly provided for in a will.
